■Event Regulations

The Event Regulations outline the compliance requirements for applicants and participating runners of the Tokyo Marathon Friendship Run 2024.

- 1. This event will be carried out while abiding by all domestic laws and regulations.
- 2. In addition to the Event Regulations, the event will adhere to the all other rules and regulations set forth by the event organizer.
- 3. The event organizer will not be liable to any detriments caused by the following:
- (1) Illness, communicable disease and/or accidents (excluding emergency treatment).
- (2) Loss and/or damage of personal property.
- (3) Late arrival to the race due to trouble with public transportation and/or poor road conditions.
- 4. Runners are required to follow the instructions of the event organizer and the event operators. Otherwise, runners will be disqualified from participation in the event.
- 5. Copyright of images, photographs, articles, coverage of the event, and the usage and management rights for TV broadcasting, newspapers, Social channel, magazines and the Internet, belongs to the event organizer. Aforementioned copyright includes but is not limited to names and other personal information such as age and address (country, prefecture and city only) and of entrants mentioned in articles covering the event as well as any appearance of event participants. This information may be provided to joint sponsors, management, operations, individual sponsors, sponsor companies, and other authorities at the organizer's discretion. By agreeing to these regulations, you are providing consent to the above.
- 6. The event organizer, in recognition of the importance of protecting personal data, abides to all laws and ordinances concerning the protection of personal data, and adheres to the event organizer's privacy policy when handling personal data.
- 7. The event organizer will provide adequate first aid to injury and illness during the race event.
- 8. Regarding medical relief during the Friendship Run, the following will apply:
- (1) In necessary cases the organizer will arrange an ambulance or rescue vehicle in order to transport the patient to the nearest hospital (participants will be responsible for any medical expenses incurred).
- (2) In the event that a participant is transported to the hospital and medical examinations are performed, medical records will be requested from the institution which provided care.
- (3) Please note, in case of emergency, life-saving activities are given top priority and the opposite sex may execute the operation (usage of AED, chest compression, treatment at first aid stations, etc.).

■Entry Regulations

Applicants who do not comply with the below regulations will have their registration voided, no refunds will be made. Non-compliance will result in a ban from future participation.

- 1. A duplicate application by the same applicant is prohibited. If duplicate entry is discovered, the entry will be voided and the paid entry fee will not be refunded.
- 2. False declarations of name (verifiably connected to an individual), date of birth, sex, nationality, and residing address are strictly prohibited. Please carefully check all registered information for it cannot not allowed to be changed or canceled after submission.
- 3. The organizer will not be held responsible for any late entry due to error caused by technological devices, operating systems, browsers, and/or poor Internet connectivity.
- 4. Email delivery check for the registered email address will not be conducted. Note, the organizer will not be responsible for any inconvenience or loss due to trouble with the device (malfunction), system/email setting, and failure to receive mass email and/or change in email address.
 - *If the email in use at time of registration has changed, please be sure to contact the Entry Desk to update your information.
- 5. Entry desk and administration office will not accept any contact regarding entry status. For details, please refer to emails sent by the event organizer.
- 6. Applicants who fail to pay the entry fee and other owned/required fee by the designated date will have their entries cancelled (voided) automatically, and will not be allowed to participate in the race. Putting the right of entry or the athlete bib for sale, resale, auction, or as part of a sales campaign as promotion is strictly prohibited. Any participant guilty of breaching this rule will be disqualified, and the entry fee will not be refunded.
- 7. No refunds will be made for overpayment or duplication of the entry fee, cancellation of entry due to violation of rules and regulations, or in the case of withdrawal for personal reasons.
- 8. Participation by an individual other than the applicant (proxy entrants, transferred rights, etc.) is not permitted.
- 9. The event may be cancelled for any of the following reasons. If the event is cancelled for the reasons stated below, the entry fee will be fully refunded.
 - Cancellation in the case that the course obstructed due to snow, a rise in water levels from heavy rain or due to damage to buildings or other structures caused by strong winds, lightning strikes, tornadoes, or fi res in the vicinity.
 - Cancellation in the case that there is a physical incident occurs during which runner safety cannot be guaranteed and police request that the course be vacated.
 - · Cancellation due to an earthquake in Japan.
 - Cancellation due to a J-Alert (excluding war or terrorism).
 - Cancellation of the Tokyo Marathon 2024 or this event due to a request from a government agency.
 - Cancellation due to reasons other than those specified above.
