

Tokyo Marathon Friendship Run 2025

■1■Event Regulations

The Event Regulations describe the rules that entrants of the Tokyo Marathon Friendship Run must comply with.

1. This event will be carried out while abiding by all domestic laws and regulations.
2. In addition to the Event Regulations, the event will adhere to the all other rules and regulations set forth by the event organizer.
3. The event organizer will not be liable for the following:
 - (1) Illness, communicable disease and/or accidents (excluding first aid).
 - (2) Loss and/or damage of personal property.
 - (3) Late arrival to the race due to trouble with public transportation and/or poor road conditions.
4. Runners are required to follow the instructions of the event organizer and the event staff. Otherwise, runners will be disqualified from participation in the event.
5. Copyright of images, photographs, articles, coverage of the event, and the usage and management rights for TV broadcasting, newspapers, magazines and the Internet, belongs to the event organizer. Aforementioned copyright includes but is not limited to names and other personal information such as age and address (country, prefecture/state/province and city only) of entrants mentioned in articles covering the event as well as any appearance of event participants.

This information may be provided to joint sponsors, management, operations, individual sponsors, sponsor companies, and other authorities at the organizer's discretion. By agreeing to the Event Regulations, you are providing consent to the above.
6. In recognition of the importance of protecting personal data, the event organizer complies with all relevant laws and ordinances concerning the protection of personal information, and the event organizer's privacy policy.
7. The event organizer will provide adequate first aid to injury and illness during the event.
8. The following medical aid will be provided during the event:
 - (1) The event organizer will arrange an ambulance or rescue vehicle in case a patient needs to be transported to the nearest hospital (please note that participants will be responsible for any medical expenses incurred).
 - (2) In the event that a participant is transported to the hospital and medical examinations are performed, the event organizer will request that the hospital provide medical records.
 - (3) Please note that life-saving activities are given top priority in case of emergency, and the opposite sex may execute the operation (usage of AED, chest compression, treatment at first aid stations, etc.).

■2■Race Regulations

The event organizer will not permit the participation in the event who is in violation of the event regulations, laws/regulations, or public order and morals, as well as the prohibitions specified in the following examples 1 through 12.

If any of these are applicable to the participant, the event organizer will not allow the participant to join the race or prevent the participant from continuing the race, even after the start of the event. Any objection against its judgement will not be accepted.

1. Dressed in clothing or wearing a gear that may be dangerous, hurtful or cause other runners to fall; and/or running with the whole part of the face covered.
2. Dressed inappropriately for a sports event or in clothing that is unpleasant to other participants or spectators.
3. Clothing for the purpose of political or religious assertions or propaganda, as well as advertising.
4. Clothing for the purpose of promoting or advertising an individual name, a specific region or an organization that the event organizer does not acknowledge.
5. Use of articles that could cause other participants to mistakenly recognize as a starting signal and cause confusion

to the race management, or use of a devices with strong sound volume that may disturb others.

6. Acts that causes a delay to the start of the event, such as, dancing, performance, playing instruments, standing near the start or finish lines, or in the streets along the course.
7. Soliciting monetary contributions, signatures, etc.
8. Preventing pedestrians from crossing the course or obstructing the passage of emergency vehicles at certain points, when and where they are allowed to do so.
9. Obstructing the race by failing to follow the instructions by the race officials and referees.
10. Bringing a guide runner not approved by the event organizer. Also, guide/support animal is not allowed.
11. Changing clothes in undesignated locations and/or urinating or defecating at places other than toilet facilities.
12. Occurrence of affair other than those listed in numbers 1 through 11 that the event organizer determine inappropriate for the event.

■3■Entry Regulations

Applicants who do not comply with the below regulations will have their registration voided (no refunds will be made), and will no longer be able to participate in the future events.

1. A duplicate application by the same applicant is prohibited. If duplicate entry is discovered, the entry will be voided and the paid entry fee will not be refunded.
2. False declarations of name (verifiably connected to an individual), date of birth, sex, nationality, and residing address are strictly prohibited. Please carefully check all registered information before submission. Registered information cannot be changed or canceled after submission.
3. The event organizer will not be responsible for any late application due to technical problems caused by devices, operating systems, browsers, and/or poor Internet connection.
4. The event organizer will not check whether emails have been delivered to applicants' email address. Please also note that the event organizer will not be responsible for any inconvenience or loss due to trouble with the device (malfunction), system/email setting, and failure to receive mass email and/or change in email address.

*If the registered email address has changed, please be sure to contact the Entry Desk to update your information.
5. The Entry Desk and administration office will not accept any contact regarding entry status. For details, please refer to emails sent by the event organizer.
6. Applicants who fail to pay the entry fee and other owned/required fee by the designated date will have their entries canceled (voided) automatically, and will not be allowed to participate in the race. Resale, auction, and campaign usage of the right of entry and the athlete bib (number card) are strictly prohibited. A participant who is in violation of any the above rules will be disqualified and the entry fee will not be refunded.
7. No refunds will be made for overpayment or duplication of the entry fee, cancellation of entry due to violation of rules and regulations, or in the case of withdrawal for personal reasons.
8. Participation by an individual other than the applicant (proxy entrants, transferred rights, etc.) is not permitted.
9. If the decision is made to cancel the event, event fees may be refunded, depending on the timing of the decision and the reason for the cancellation. For more details, please refer to 14 of the "Tokyo Marathon 2025 Entry Regulations":
